

INFORMATION NOTICE ON PROTECTION OF PERSONAL DATA This Information Notice deals with the processing and transferring of the personal data of the natural persons as regulated by the Law no. 6698 on Protection of Personal Data. In line with the importance we attach to the security of your personal data as ERIM ARIKAN YAG FOOD AND CONSTRUCTION INC. , your personal data will be stored during due time in the safest manner and under the conditions set forth by the relevant regulations and legal liabilities. Your personal data may be processed under the conditions and for purposes of processing personal data as specified in Articles 5 and 6 of the Law No. 6698, for the fulfillment of the liabilities of both our firm and the natural and legal persons in a business relationship with our firm, to communicate the updates, to set and conclude the contracts to be entered into with you, to remind and fulfill any legal liability, to perform any advertising and marketing activity, to get your opinion through survey and voting, to determine the appropriate product, project and service for you, to customize and develop the same, to provide effective customer service, to notify any change in legislation and company policies that concern you or to make other notifications concerning you, to inform you for the matters concerned by electronic mail, SMS and fax, to define our visitor profiles, to evaluate the requests, demands and complaints and to implement our firm's HR policies, to respond to your requests and questions. Your personal data shall be processed in good faith pursuant to the relevant law for proper, if necessary up-to-date, certain, explicit and statutory purposes and shall be retained for a limited and constrained period of time as per the purpose for which they are processed as specified in the relevant legislation or as required for the purpose of processing. Furthermore, the personal data may be shared with our direct/indirect local/foreign affiliates or subsidiaries, local/foreign/international public/private institutions and organizations, companies and other 3rd parties from whom our company receives services/support/consulting services or the ones with whom it is in cooperation or any project/program/financing partners, our company's subsidiaries, consultants, shareholders or other group companies like solution partners, Central Registry Agency and other authorized institutions and organizations, suppliers and subcontractors provided the conditions set forth in Articles 8 and 9 in the law on the protection of personal data are observed and the necessary security measures are adopted as limited to the purposes listed under Article (b) of this notice and in accordance with the terms and purposes of personal data processing set forth in Articles 8 and 9 of Law No. 6698. ERIM ARIKAN YAG FOOD AND CONSTRUCTION INC. may process and store your personal data through the servers at home and abroad provided that it observes necessary security measures. Your Rights as a Personal Data Subject In the event as a Personal Data Subject you

communicate your claims for your rights to our Company pursuant to the methods set forth below, our Company shall fulfill your claim free of charge as soon as possible, in any case no later than thirty days up to the nature of your claim. However, if any fee is charged by the Personal Data Protection Council, the specified in the relevant tariff shall be charged by our Company. In this context, personal data subjects shall have the right to know whether his/her personal data is processed; to request information if his/her personal data has been processed; to know the purpose of processing his/her personal data and whether such data have been used appropriately for their purpose; to know the third parties to whom his/her personal data have been transferred domestically or abroad, to request rectification in case his/her personal data have been processed incompletely or inaccurately; to request deletion or destruction of personal data within the framework of the conditions stipulated in the relevant legislation; to request notification of transactions performed as a result of requests for correction, deletion and destruction of personal data to any third parties to whom personal data has been transferred; to request notification of transactions performed as a result of requests for correction, deletion and destruction of personal data to any third parties to whom personal data has been transferred; to demand the compensation of damages and losses suffered due to the unlawful processing of personal data. In accordance with Paragraph 1 of Article 13 of the law on the protection of personal data, Data subjects may use their abovementioned rights by using the "Form for Applications to be Filed by Personal Data Subjects to Data Controllers" or any other method specified by the Personal Data Protection Council in written or via registered electronic mail (KEP) using secure electronic signature or sending the same to the following address "ERIM ARIKAN YAG FOOD AND CONSTRUCTION INC.
